Release Notes for ETM[®] System v5.2.1 Update 2

Who Should Install This Software

ETM[®] System v5.2.1 update 2 is recommended for customers using the call termination functionality. To obtain the update, visit <http://support.securelogix.com/updates/index.htm>. It is a cumulative software update that includes all fixes and enhancements issued since Release 5.2.

This software update can only be installed on ETM System Software v5.2. If you are running a previous version of ETM software, please contact your Account Executive or SecureLogix Customer Support for updated software.

About This Document

This document contains important information about ETM System v5.2.1 update 2. The ETM System includes the ETM Communications Appliances, ETM Server software, and the ETM applications: the Performance Manager, the Voice Firewall, the Usage Manager, AAA Services for the Voice Firewall, the Voice IPS (Intrusion Prevention System), and the Call Recorder.

New Feature in this Update

- **Short Duration Terminator Notification** – When installing a termination policy that has ambiguous Source and Destination values (Source and Destination set to “any”) and a Duration shorter than 5 minutes, the user will receive a pop-up message informing them that such a rule could lead to terminating a large number of calls

Issues Addressed in this Update

- 6293 - Unexpected DSP restart triggers Host Command Failed Errors
- 6835 - Duration objects truncated to remainder of 12 hours
