Who Should Install This Software

ETM[®] System v5.0.2 Update 8 is recommended for all customers running v5.0.2 software. To obtain the update, visit <http://support.securelogix.com/updates/index.htm>. It is a cumulative software update that includes all fixes and enhancements issued since Release 5.0.2.

This software update can only be installed on ETM System Software v5.0.2. If you are running a previous version of ETM software, please contact your Account Executive or SecureLogix Customer Support for updated software.

About This Document

This document contains important information about ETM System v5.0.2 Update 8. The ETM System includes the ETM Communications Appliances, ETM Server software, and the ETM applications: the Performance Manager, the Voice Firewall, the Usage Manager, AAA Services for the Voice Firewall, the Voice IPS (Intrusion Prevention System), and the Call Recorder.

Issues Addressed in this Update

- Daylight Savings Time changes in 2007-2008
 - *This update must be run on all ETM Client systems as well as the ETM Management Server and ETM Report Server systems for the DST changes to be effective.*
